The Chester Township Board of Trustees met in special session **Thursday, March 31, 2022** in the Town Hall Meeting Room at 8:00 AM Chairman Ken Radtke presided.

## Pledge of Allegiance to the Flag

The Board led the audience in reciting the Pledge of Allegiance to the Flag.

Joe Mazzurco explained the quote for landscaping. The bid application was sent out on two different occasions and only one bid was received. The cost breakdown for the Park is \$23,047.73, Town Hall is \$4,807.66 and the Fire Department is \$3,347.12. This includes cutting the grass, fertilizing, blowing off all of the hard surfaces, trimming, mulching and then summer mulching and fall leaf blowing. The cost to maintain the ballfield this year will be \$116.75 to drag the field and stripe it, which gets done before every game. The HS is presently playing 10 games at the field and then in the summer time the cost is split with the WG Baseball Federation. Mr. Radtke asked about reaching out to the school and splitting the cost with them also. Joe Mazzurco stated we haven't in the past but can ask them. The field needs to be prepped prior to the season, it's \$51.25 per man hour and \$45.00 per hour for the machine. It's approximately 15 hours of prepping, total, and they will line it so there will be the onetime lining fee in spraying the grass all the way down to the foul poles and then provide a case of striping paint and after that they will charge us an hourly wage to do the striping. An hourly rate is only charged when they are on site. Mr. Mazzurco told the company they would not get any fuel surcharges so that needs to be incorporated in the cost ahead of time. Other companies are charged fuel surcharges by other companies. The contract is for one-year of service. The grass cutting is \$10,000 higher this year due to gas and labor issues. We can't use Road Department employees due to a shortage in summer help. We usually have two people this year we only have one person and we have things already that need to be cut in the town. In past years we tried to offset the cost by having our people do the labor, going through beds weekly, keeping them 95% weed free, so there are a lot of services that have to be repeated weekly.

Linda Gifford asked if the seasonal worker that quit is the one just recently hired and has he even started working? Mr. Radtke replied he had not started. So why did he quit? Mr. Radtke asked the other Trustees if he gave a particular reason.
