Department Business – Fire

Instituted a community paramedicine/community health worker program to help elderly patients receive follow up care while in their home;

Helped institute a quality assurance program for Department EMS care to ensure adequate patient care by Department staff improving the care delivered.

Chester Township thanks her for her years of service on behalf of the people and fire service of the Township and wish her well in her future endeavors."
