The Chester Township Board of Trustees met in regular session **Thursday, July 14, 2022** in the Town Hall Meeting Room at 5:47 P.M. Chairman Ken Radtke presided.

Roll Call: All Trustees and the Fiscal Officer were present.

Pledge of Allegiance to the Flag

The Board led the audience in reciting the Pledge of Allegiance to the Flag.

<u>Department Business – Police</u>

2022-280. Mr. Radtke moved to approve the hiring of Tyler Dankovich to the position of full-time police officer effective Sunday, July 17, 2022 at the 2022 Step 3 Officer classification/pay grade of \$32.64 per hour. Mr. Richter seconded. Vote unanimous; motion passed.

Chief Young spoke well of Officer Dankovich, who has been a certified peace officer for seven years. Officer Dankovich was then sworn in by Trustee Radtke.

Mr. Radtke made a statement regarding rumors that the Board of Trustees was voting on the zoning amendment presented at last night's Zoning Commission meeting. The Board of Trustees would need to hold a public hearing of their own at a future date. He encouraged people to not rely on what they see on social media.

In the absence of the Zoning Commission Chair, Trustee Radtke provided a summary. This amendment is a recommendation to take two 2-acre parcels currently zoned residential with a variance, and changing them to commercial.

Attorney Joe Weiss stated the property is at 8833 Mayfield Road, in the area just past the power lines on the south side of the street. In the 1960s, the owner appealed the case and in a 1963 decision the court of appeals approved the variance.

Dave Dietrich, former Director of the Geauga County Planning Commission, stated that the Auditor already considers this as commercial. The intent is to consolidate both parcels (11-203500 and 11-203600) into one. Mr. Dietrich provided more detail on the property.

Margaret Muehling gave a description of Chester Township's definition of commercial zone as it appears in the Zoning Resolution.

2022-290. Mr. Radtke moved to close the public comment portion of the public hearing. Mr. Richter seconded. Vote unanimous; motion passed.

2022-291. Mr. Radtke moved to close the public hearing at 6:42 PM for zoning amendment Z2022-1. Mr. Richter seconded. Vote unanimous; motion passed.

Public Comments/Questions

The public had no comments or questions.

Barry Leven – Pickleball court update

Mr. Leven gave a background on how the pickleball court idea evolved. There will be three courts, located in the grassy section near Mayfield Road and the volleyball court area. The ODNR grant amount has been lowered to \$16,402.00. A fundraiser has been started, to raise approximately \$40,000 to complete the project. Mr. Leven asked the board to approve \$25,000 from the Township toward the project. NOPEC has grants as well, and Mr. Leven anticipated \$27,500 from them for the lighting. The total cost is now down to \$102,887.00. The Chester Park Board would also contribute \$10,000. There has been great interest in contributing. A Go Fund Me account will also be set up.

Kelly Baeslach asked why not wait to see how much can be raised before asking the Township for money. Mr. Richter stated that the board had been approached and was amenable to contributing \$25,000 prior to tonight; this was a recommitment. Mr. Radtke said it would also encompass labor and materials from the Road Department. Kiwanis would contribute, and Rotary and Lions Club would be approached.

Jane Stark asked if there was a pickleball league. Mr. Leven said there are four outdoor courts in Geauga County. The Parkside courts would be lighted as well. Mr. Radtke committed to a personal donation.

2022-299. Mr. Radtke moved to commit up to \$25,000 in labor, equipment, materials and money for the construction of the Chester Township pickleball courts at Parkside Park. Mr. Richter seconded. Vote unanimous; motion passed.

<u>Department Business – Road</u>

Township Administrator Purchase reported on the Police Department building's catch basins and related issues. The Road Superintendent has been instrumental in mitigating costs. Mr. Purchase is also working with Superintendent Onyshko near the Woodside plaza development drainage. Mr. Onyshko has kept the board up to date with emailed information on drainage. Mr. Onyshko recommended sending a camera down the main chute by the Police station.

Paulette Gaia questioned the larger size of her culvert as opposed to what is required on Woodside. Road Superintendent Onyshko explained that she was actually higher than the Woodside culvert and there would be no impact to her from this project on Mayfield Rd..

Township Administrator

Tomorrow the red brick and concrete in Parkside Park would be pressure washed. Mulch is on the way, and the slide is due for repair on July 19. Park electrical is mapped out. The gazebo needs painting.

Progress is being made on the Township website redesign, and a kickoff meeting is anticipated next month.

Regarding the reserve fund, Miller Dotson has given the Township a quote to evaluate all the properties and vehicles. The total cost is approximately \$10,000.

At the Recycle Park, the shed is up now for people to drop off boxes. The clothing bin is back as well. The sign for the entrance announcing camera usage should be ready tomorrow, and the Road Department would install it. Five or six residents have been contacted already regarding non-recyclables left at the area and have returned to remove these materials from the site.

Linda Nissin asked if a sign would be placed on the barn regarding "take a box leave a box" to explain it to people.

At the quarterly GTA dinner, Administrator Purchase asked if any other communities in the county that opted out of the new fireworks law; there were none. The police only received 5 complaints about fireworks with no arrests, confiscations or injuries.

Ven Paoletto asked if fireworks were permitted. Mr. Purchase stated it is limited to certain fireworks and there are time limits as well.

<u>Department Business – Police</u>

2022-301. Mr. Radtke moved to accept after the fact the resignation of Sean Day from the rank of Sergeant with the Chester Township Police Department effective July 10, 2022. Officer Day will be reverted to Step 5 Officer classification which entitles him to an hourly pay rate of \$35.34/hour or \$73,499.88 annually. Mr. Richter seconded. Vote unanimous; motion passed.

An error was also made in the original motion regarding the dollar amount which should have been \$275.00. Kelly Baeslach suggested keeping Alan Weinstein because he seemed to know a lot. Linda Gifford disagreed, stating Mr. Weinstein is an urban planner. Mr. Radtke asked the Trustees if they wanted to instill a time limit for speaking, for future public hearings.
