Township Administrator

Township Administrator Purchase has applied for a \$500 OTARMA safety grant for Parkside Park, intending to apply the funds to the playground mulch invoice. A Cleveland Guardians grant is available, which would replace some of the bleachers on the ball field. WGHS varsity softball wants to use Parkside as their home field next year. Field upkeep costs would be shared. Electrical issues have been repaired, the walkway and gazebo floor have been pressure washed. Administrator Purchase would contact First Energy to increase the service from the pole to the gazebo to 100 amps. This would help the holiday lighting issues. The Recycle Park sign regarding cameras will be installed shortly. Kiwanis has painted the fence at the site. The Township has been awarded nearly \$15,000 of Go Green grant money to address the driveway of the site.

There will be no hearings for the Board of Zoning Appeals in August. Many resident complaints regarding inspections have been received and are being investigated. HB 563 has cleared committee and is on the floor for vote, proposing to take away a Township's ability to zone rental properties, potentially resulting in anyone being able to rent their properties to anyone, including AirBnB, Vrbo, etc. Mr. Purchase drafted a letter for Chester Township in opposition to the bill; copies would be provided to the Trustees.

Linda Gifford called Diane Grendell regarding the bill, stating why she was against it. Ms. Grendell is also not in favor of the bill. The state representative who brought the bill forward owns a B&B, which is a conflict of interest.

Reserve funds are set aside for unplanned, unanticipated expenses. Prior to setting the funds up, an inspection of the Township properties and heavy equipment is required. Monies are set aside annually for each department. Russell Township shared their report regarding reserve funds. Mr. Purchase and the Fiscal Officer planned to have this in place by the end of 2022. Miller Dodson company was chosen on a recommendation from other Townships.

Dear Representative Fowler Arthur:

The Chester Township Board of Trustees is unanimously opposed to proposed H.B. 563 as introduced. This legislation, as currently written (with certain exceptions), prohibits a township from adopting or enforcing any regulation or restriction that prohibits short-term rental properties or regulates the number, duration, or frequency of rental periods for short-term rental properties.

Ohio Revised Code (ORC) Section 519.2 enables a board of township trustees to regulate the use of real property through zoning for the purpose of promoting and protecting the public health, safety, and general welfare. Local zoning is how communities control land use and ensure complimentary development. It helps communities plan and has served townships for the past 75 years. The issue of shortterm rentals is not as simple as whether to allow them or not -- it's about where they are located and what makes sense for the community. For townships, the issue of shortterm rental regulation is, at its core, a local zoning issue. As elected officials charged with responsibility for the general welfare of our community, we would be negligent in those duties if we failed to consider the very real and potentially negative impact that short term rental, could invite into our neighborhoods. If H.B. 563 moves forward, there can be no disputing the fact that the potential for increased crime, noise and disruptions within our community will be present and will impact our local safety forces, in one capacity or another. We urge you to ensure our ability to manage and regulate what is best and safe for our community, continues through local zoning laws and that must include our ability to manage and restrict short term rental properties.

Whereas we certainly understand and agree with the exemptions to township zoning regulation of certain uses (such as agriculture) as currently set forth in ORC Section 519.21, allowing short-term rental property as defined in the proposed legislation virtually anywhere in a township could have serious detrimental impacts – particularly in a single-family residential zoning district. Essentially, as defined in the proposed legislation, this is a commercial use in a residential zone.

Again, it is contrary to the very purpose of zoning: to divide a township into districts that are uniform in terms of each class or kind of use in order to promote and protect the public health, safety, and general welfare. This is a bedrock principle of zoning pursuant to the decision by the U.S. Supreme Court in the case of Euclid v. Ambler Realty Co. 272 U.S. 365 (1926).

Thank you for carefully considering our position regarding this matter.
