The Chairman welcomed everyone to the meeting and the Board said the Pledge of Allegiance.

Discussion by the Park Board Members:

The Park Board members discussed park district insurance, and to make certain that Memorial Park and 80 Acres are included in the policy. Barry Leven discussed the Pickle Ball Courts project with the board. His group is looking for funding to complete the project. Anthony Nastasi is working on drawings of the plans for the courts. Joe Fornaro shared information from Kirtland’s Pickle Ball construction. Bob Somrak discussed the restroom remodeling project ideas, and suggested putting fencing around the sides of the park dumpster. Discussion ensued about the proposed location for bocce courts. There is enough room for a walkway east of the available court space. Mark Purchase reported that township trustees agreed to move forward with repairs and fencing at the park. Peerless Electric has fixed the lampposts and Playground World Park n’ Play is scheduled to come out to do needed work. Playground mulch is needed. Mark Purchase is going to get prices for new lightbulbs for volleyball court. The gazebo needs painted.


