Mr. Richter wanted it clarified that the memorandum of understanding is between Chester Township and the West Geauga School Board since the memorandum says Chester Township Police Department and the West Geauga School Board. There will be a safety officer in the elementary school and middle school. We already have a School Resource Officer in the high school. The community was paying for 50% of the High School Resource Officer. However, now the expense will be paid through the school.

Police Chief Young shared the placement of officers in all schools has been in the works for some time and the School Board and the Police Department have worked hard to accomplish this. He is excited to bring Karen Sweet into the new position since she brings 34 years police experience with her. She was instrumental in mentoring detectives and officers in both Geauga and Lake County. Her overall knowledge and experience makes this a good decision for the community.

Mr. George Minello shared what a nice job the Kiwanis group did on the 4th of July parade. He was excited to see the turn out for the parade and would hope that recognition is in the local paper.

Mr. Richter shared the pickleball project began a year ago with multiple variations and it was recently sent out to bid. The bids were much higher than expected. Mr. Richter said House Bill 33 raised competitive bidding from \$50,000 to \$75,000. Mr. Barry Leven spoke about the cost and the price increase in just a year. Discussion continued with thoughts of making some changes from the initial plans to help reduce cost. Mr. Radtke and Mr. Leven will continue to work on the project and have items prepared for next meeting.
