Peerless Electric is working in the gardens regarding the electrical issues. Upon completion of this project, the Township will then ask for additional work requested by Rotary. The Chamber of Commerce is looking at selling Christmas trees to a business or an organization and having them decorated and using this as a fundraiser. They would like to utilize the park. The cemetery project is moving forward.

Mr. Mazzurco will gather all the information and submit paperwork to NOPEC around November 20th. Mr. Purchase said in the spring he would like to have the pieces of rotted wood replaced on the Town Hall building and add a fresh coat of paint. Finally, he would like to address signage on the front of the Town Hall building.

To date, Rotary has not submitted any bills.
