Township Administrator

Mr. Purchase shared the furnace is fixed at Town Hall. The one furnace is 27 years old and will need to be replaced. This will be revisited in January of 2024. Hoping to put through NOPEC. Some street lights are out in the Township, so LED lights should be replacing them. Looking into converting old lights in center of town to LED lights through First Energy and utilizing NOPEC funds.

A resident asked what the noise policy is in a residential area regarding when someone can start a project. Chairman Richter said we do not have a noise ordinance. Trustee Radtke said he would be glad to provide the section in zoning that relates via e-mail. It was stated the noise is coming from garbage trucks at 5:15 A.M.

Mr. Purchase added he completed the grant funding request for the salt dome and is now working on the grant for the roof of the road department building. Estimating approximately \$300,000 project cost with a request for 50% or \$150,000 from the State of Ohio. It was confirmed the bones are good on the building and it can sustain a new roof. Trustee Radtke said we may want a true analysis including the cost and may want to consider an additional levy to request replacement only of the existing fleet. Mr. Purchase held a meeting today with several people including representatives from the Village of Gates Mills regarding the County Line Road project. Gates Mills is in agreement that it makes sense to do County Line Road in conjunction with Chester. Chester Township may have a number closer to \$975,000 plus about \$100,000 because of the concrete headwalls. It is not an actual pipe, it's a concrete basin and water travels underneath it. Gates Mills appears to be on board with splitting the cost. Road Superintendent Onyshko and Township Administrator Purchase will meet tomorrow and discuss what road projects may be able to be pushed back in 2024. Conversation continued regarding the cost of different projects. Mr. Mazzurco thinks the \$300,000 estimated project cost for the roof may be low with the electrical and additional work needed. Mr. Purchase reminded the Board that our estimates need to be as close to actual as possible. Mr. Purchase said it was made clear at the meeting that Townships could send in as many projects as they want since there is no limit. The parking lot for the Park was discussed briefly. It was suggested maybe putting in for \$300,000 for parking lot paving.

Resolution # 2023-488.

A RESOLUTION TO PROHIBIT ADULT-USE CANABIS OPERATORS AND MEDICAL MARIJUNA CULTIVATORS, PROCESSORS, AND RETAIL DISPENSERIES WITHIN THE UNICOROPORATED AREAS OF CHESTER TOWNSHIP, GEAUGA COUNTY

Trustee Craig Richter, moved that the following Resolution be adopted:

WHEREAS, on November 7,2023, voters in Ohio approved State Issue 2, which enacts new Chapter 3780 of the Ohio Revised Code, effective thirty days from the date of the election; and

WHEREAS, Chapter 3780 authorizes and regulates recreational adult-use cannabis in the state of Ohio; and

WHEREAS, R.C. 3780.25 authorizes townships to prohibit or limit the number of adult-use cannabis operators (as defined in R.C. 3780.01) within the unincorporated area of the township; and

WHEREAS, Medical marijuana is regulated in Ohio by Chapter 3796 of the Ohio Revised Code; and

WHEREAS, R.C. 3796.29 similarly authorizes townships to prohibit or limit the number of marijuana cultivators, processors, or retail dispensaries licensed under Chapter 3796 within the unincorporated area of the township; and

WHEREAS, the Board of Trustees finds it to be in the best interest of the township to prohibit adult-use cannabis operators licensed under Chapter 3780, as well as cultivators, processors, and retail dispensaries licensed under Chapter 3796, within the unincorporated area of the township;

Now, therefore, be it RESOLVED, as follows:

- 1) All terms used in this resolution shall be defined in the same manner as R.C. Chapter 3780, as it pertains to adult-use cannabis. All terms used in this resolution but not defined in those chapters shall be construed, for purposes of this resolution, in a manner consistent with the use of such terms in both chapters.
- 2) Adult-use cannabis operators, as well as cultivators, processors, and retail dispensaries of medical marijuana are hereby prohibited from operating within the unincorporated are of Chester Township, Geauga County, Ohio
- 3) It is the intent of the Board of Trustees to limit operations described in Section 2 above to the maximum extent permitted by R.C. 3780.25, and RC 3796.29, any other applicable provisions of state law. This resolution shall be construed in a manner that gives maximum effect to that intent.

Mr. Mazzurco seconded.
